LEAF PICKUP

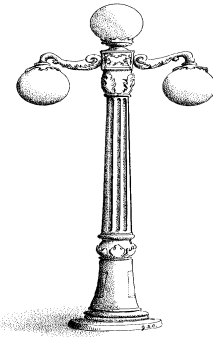
Leaf pickup season is again upon us. On September 19th the Borough began the annual leaf pickup. Residents are reminded to place leaves beside the curbs on the day their street is posted No Parking 7 AM until Noon. The leaf truck will be followed by the street sweeper so please observe the posted times for No Parking. **Any violators WILL HAVE their vehicles towed at their expense.** Your assistance will aid in the efficiency of this process. The leaf truck will operate through Friday, November 25th. Residents are reminded that leaf collection is for their benefit and the benefit of the Borough. Collection of leaves avoids blockage of storm sewers and inlets which causes unnecessary flooding.

PROPERTY MAINTENANCE

Residents are reminded to keep their properties clear of debris and in good repair. This is not only beneficial to individual homeowners, but the community as a whole. TREE TRIMMING CURBSIDE COLLECTION

The Borough will be conducting curbside collection of tree trimmings during the week of Monday, October 17th through Friday, October 21st. This is a semi-annual event that will follow the normal street maintenance schedule. Tree trimmings should be bundled. Trimmings must be no larger than 2" in diameter and 4' in length. All other tree trimmings can be taken to the brush pile during normal hours of operation.

SNOW REMOVAL



The Borough would like to remind all property owners that it is your responsibility to keep your sidewalks clear of snow and ice. By Ordinance, you have **12 HOURS** after the snow has ceased to fall or the ice has ceased to form to perform such removal. Failure to do so will result in a fine and possible removal by the Borough with costs to be passed along to the owner. We thank you for your cooperation in this effort.
