LEAF PICKUP

Leaf pickup season is upon us. On September 18th the Borough began the annual leaf pickup. Residents are reminded to place leaves beside the curbs on the day their street is posted No Parking 7 AM until Noon. The leaf truck will be followed by the street sweeper so please observe the posted times for No Parking. **Any violators WILL HAVE their vehicles towed at their expense.** Your assistance will aid in the efficiency of this process. The leaf truck will operate through Friday, November 24th. Residents are reminded that leaf collection is for their benefit, as well as the benefit of the Borough. Collection of leaves avoids blockage of storm sewers and inlets which cause unnecessary flooding.

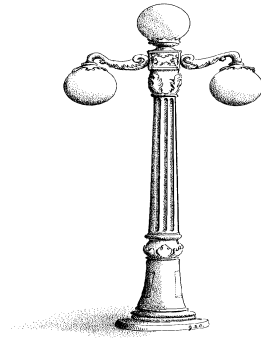
2018 STREETS IMPROVEMENT PROJECT

Borough Council has selected the streets to be improved as part of our 2018 Streets Project. We expect this work to be completed in late spring or early summer of next year. Below are the streets expected to be included in the project:

- 1) Terrace Street from St. Paul Street to North Fifteenth Street;
- 2) Meadow View Court;
- 3) Ogren Alley;
- 4) North Third Street from Beck Street to Market Street;
- 5) Cherry Alley from North Fourth Street to North Third Street and a small section of Peach Tree Alley;
- 6) Cherry Alley from North Seventh Street to Linn Alley;
- 7) South Second Street from St. Louis Street to St. George Street and the St. George Street intersection;
- 8) White Pine Alley from South Third Street to South Second Street and Apple Tree Alley from White Pine Alley to St. Louis Street.

In addition, the Borough expects to undertake a Streetscape Improvement Project on South Sixth Street in the summer of 2018.

RECYCLING CENTER & BRUSH PILE

The Borough's Brush Pile and Recycling Center remain open every Wednesday from 8 AM to 4 PM and every Saturday from 8 AM until Noon. They are both located in the Wolf Field Complex.

Recycling Center

The Borough has changed how it handles the recycling of electronic items. Due to increasing costs associated with the recycling of electronic items, the Borough will no longer accept electronic item drop-offs at the Recycling Center. Residents who wish to recycle electronic items should contact the Borough Office to schedule a special pick-up by our Borough Crew. As with other special pick-up items in the Borough, a small fee will be charged to cover the costs associated with the collection and recycling of these electronic items. Electronic item special pick-ups will take place once a month.

Brush Pile

The Borough's brush pile is provided for Borough residents and Borough property owners (while working on their Borough properties) to dispose of leaves, branches, and other brush materials. It is posted for use by Borough residents only. Please bring proof of Borough residency (such as your Driver's License) or proof of property ownership in the Borough (such as a copy of your property tax bill) when you visit the Brush Pile. Our staff at the Brush Pile will ask to review this information before you will be allowed deposit the brush materials. If you have a contractor working on your property and they wish to dispose of their materials at our brush pile, please come into the Borough Office in advance to get a preapproval receipt, which will allow them to dispose of approved materials at the brush pile from your property.



TREE TRIMMING & CURBSIDE COLLECTION

The Borough will be conducting curbside collection of tree trimmings during the week of Monday, October 17th through Friday, October 21st. This is a semi-annual event that will follow the normal street maintenance schedule. Tree trimmings should be bundled. Trimmings must be no larger than 2" in diameter and 4' in length. All other tree trimmings can be taken to the brush pile during normal hours of operation.



SNOW REMOVAL

The Borough would like to remind all property owners that it is your responsibility to keep your sidewalks clear of snow and ice. By ordinance, you have **12 HOURS** after the snow has ceased to fall or the ice has ceased to form to perform such removal. Failure to do so will result in a fine and possible removal by the Borough with costs to be passed along to the owner. We thank you for your cooperation in this effort.



Also, during snow removal from the Borough streets, please observe the No Parking 7 AM until Noon hours as posted. **Failure to comply with this regulation WILL RESULT in the violator having their vehicle towed at their expense.**
