

## ADVERTISEMENT FOR BIDS

The Borough of Lewisburg (Owner) will receive sealed bids, one (1) original and two (2) copies, for the “**Lewisburg Borough Sidewalk Restoration Project**” at the **Lewisburg Borough Building, 55 South 5<sup>th</sup> Street, Lewisburg, PA 17837** until **2:00 PM** prevailing time on **Thursday, June 27<sup>th</sup>, 2019**, at which time and place, all bids will be publicly opened and read aloud.

The work for this project includes but is not limited to providing all labor, materials, and equipment for the removal and installation of concrete sidewalk on Borough streets. The work is separated into several areas across the Borough including on North 7th street, North and South 3rd street, the public parking lot between South 3rd and 4th streets, Market Street, and South 7th street. The portion of the project on South Seventh Street must be completed before **Thursday, August 15<sup>th</sup>, 2019**. All other work must be completed by **Monday, September 30<sup>th</sup>, 2019**. Final invoices must be submitted to the Borough of Lewisburg no later than **Monday, October 31<sup>st</sup>, 2019**.

Interested parties are required to register on the website for the ability to view and/or acquire contract documents and technical specifications for this project. It is the responsibility of any person or organization interested in a hard copy of the Bidding Documents to pay all costs associated with printing. Each proposal shall be accompanied by a Bidder’s Bond, or certified check or cashier’s check, in favor of the Borough, in the amount of not less than 10% of the total bid amount. No bid may be withdrawn for a period of 60-days, with the right to extend the time to 120-days if additional time is needed by the Owner. Prevailing wages established under the Pennsylvania Prevailing Wage Act will apply to this contract if the bid price is greater than \$25,000.00. The contract documents contain requirements addressing prevailing labor wage rates, labor standards, and nondiscrimination in hiring practices. Bidders must submit with their bids the Non-Collusion Affidavit contained in the contract documents and submit a certification of bidder regarding equal employment opportunity.

The Borough of Lewisburg reserves the right to waive any informality, defects, errors, omissions, mistakes, informalities, to accept any bid or combination of bids that are deemed to be in the best interest of the Borough, and to reject any or all proposals.
