Mechanic/Operator or Mechanic /Laborer in the Public Works Department

The Full time Mechanic/Operator or Mechanic/Laborer will work in our Public Works Department. The employee will typically work 40 hours or more per week. Applications can be obtained from the Borough Office, 55 South Fifth Street, Lewisburg, PA 17837 or at www.lewisburgborough.org. The successful applicant must either have or must obtain within the 90-day probationary period a Class B Pennsylvania Commercial Motor Vehicle Operator's License with Air Brakes Endorsement. A minimum of five years' experience working as a mechanic and five years' experience operating construction related equipment is required to be hired as a Mechanic/Operator. A minimum of two (2) years of experience working as a mechanic or the completion of specialized training in mechanical repair from a reputable educational or apprentice program is required to be hired as a Mechanic/Laborer. Previous experience working in the public sector or municipal government is a plus.

Position requires the ability to follow written procedures/oral instructions, perform a variety of manual tasks including mechanical repairs of equipment routinely used by municipalities, read diagrams associated with equipment, troubleshoot electrical issues on equipment, and perform heavy, repetitive, manual labor for prolonged periods, often under adverse weather conditions with random drug-testing a requirement of a CDL license. This is a full-time position with a pension and benefits as defined by a union contract. Wages during the ninety-day (90) probationary period are \$18.95/hour per the union contract. Upon successful completion of the probationary period, full-time wages for a Mechanic/Operator are \$29.48/hour per the union contract or full-time wages for a Mechanic/Laborer are \$28.06/hour per the union contract.

Temporary, Full-time Laborer I in the Public Works Department

The Temporary, Full-time Laborer I employee will work in our Public Works Department. The employee will typically work 40 hours per week Monday – Friday from 6:30 am – 3:00 pm with occasional weekend hours and weather emergency work required. The successful applicant must have and maintain a valid Pennsylvania Motor Vehicle Operator's License during the term of employment. Experience working in the public sector or municipal government a plus. Position requires the ability to follow written/oral instructions, perform a variety of manual tasks, perform heavy, repetitive, manual labor for prolonged periods, often under adverse weather conditions with random drug-testing a requirement. This is a temporary, full-time position with benefits as defined by a union contract. Wages during the 90-day probationary period are \$18.95/hour per the union contract. Upon successful completion of the probationary period, wages will be \$23.53/hour for Temporary Laborer I per the union contract.
