

ORDINANCE NO. 1028

AN ORDINANCE OF THE BOROUGH OF LEWISBURG, UNION COUNTY, PENNSYLVANIA, AMENDING SUBSECTION B OF SECTION 280-7 OF ARTICLE I OF CHAPTER 280 OF THE CODE OF THE BOROUGH OF LEWISBURG, BEING PART OF ORDINANCE NO. 82-8, ENACTED DECEMBER 21, 1982, AS AMENDED, KNOWN AS THE MUNICIPAL REFUSE COLLECTION SERVICE ORDINANCE OF THE BOROUGH, BY PROVIDING THAT THE PAYMENT OF FEES FOR THE COLLECTION AND DISPOSAL OF REFUSE SHALL BE BY THE OWNER(S) OF THE PREMISES FROM WHICH COLLECTION SHALL BE MADE, NOTWITHSTANDING THE USE OF SUCH PREMISES.

Be it enacted and ordained by the Borough Council of the Borough of Lewisburg, Union County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same, as follows:

Section 1. Chapter 280, Article I, Section 280-7, Subsection B of the Code of the Borough of Lewisburg, being part of Ordinance No. 82-8, enacted December 21, 1982, as amended, is hereby amended to read in its entirety as follows:

"B. Payment of Fees. All fees for the collection and disposal of refuse shall be payable to the Borough Treasurer by the owner(s) of the premises from which collection shall be made, notwithstanding the use of such premises. The payment of such fees shall be mandatory. No occupiers or lessees of such premises shall be directly responsible for the payment of such fees. All fees and charges shall be billed to the owner(s) on a quarterly basis."

Section 2. Except as amended by this Ordinance, Ordinance No. 914, enacted January 19, 1999, and Ordinance No. 946, enacted November 19, 2002, all of the provisions of Section 280-7 of Article I of Chapter 280 of the Code of the Borough of Lewisburg, being part of Ordinance No. 82-8, enacted December 21, 1982, shall remain in full force and effect.

Section 3. All ordinances or parts of ordinances inconsistent herewith be and the same are hereby repealed.


Section 4. This Ordinance shall become effective January 1, 2015.
