## **ORDINANCE NO. 1036**

AN ORDINANCE OF THE BOROUGH OF LEWISBURG, UNION COUNTY, PENNSYLVANIA, AMENDING SECTIONS 100-6, 100-7(E) (13), 100-8 AND 100-11 OF ARTICLE II OF CHAPTER 100 OF THE CODE OF THE BOORUGH OF LEWISBURG, BEING ORDINANCE NO. 1027, ENACTED JUNE 17, 2014, WHICH REQUIRES AND REGULATES PERMITS FOR SOCIAL GATHERINGS WHERE ALCOHOLIC BEVERAGES ARE SERVED OR CONSUMED, BY ADDING DEFINITIONS FOR "GARBAGE" AND "RUBBISH;" CHANGING WHAT IS TO BE INCLUDED IN PERMIT APPLICATIONS; AND ESTABLISHING AN ADDITIONAL GROUND FOR DENYING A PERMIT AND AN ADDITIONAL UNLAWFUL ACT CONSTITUTING A VIOLATION.

Be it enacted and ordained by the Borough Council of the Borough of Lewisburg, Union County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same, as follows:

- Section 1. Chapter 100, Article II, Section 100-6 of the Code of the Borough of Lewisburg, being part of Ordinance No. 1027, enacted June 17, 2014, is hereby amended by the addition thereto of definitions for "garbage" and "rubbish" to read in their entirety as follows:
  - "GARBAGE the animal or vegetable waste resulting from the handling, preparation, cooking and consumption of food.
  - RUBBISH combustible and noncombustible waste materials, except garbage; the term shall include the residue from burning of wood, coal, coke and other combustible materials, paper, rags, cartons, boxes, wood, excelsior, rubber, leather, tree branches, yard trimmings, tin cans, metals, mineral matter, glass, crockery, and dust and other similar materials."
- Section 2. Chapter 100, Article II, Section 100-7, Subsection E, Paragraph 13 of the Code of the Borough of Lewisburg, being part of Ordinance No. 1027, enacted June 17, 2014, is hereby amended to read in its entirety as follows:
  - "(13) Whether the Regulated Social Gathering will be utilizing interior and/or exterior spaces; and"
- Section 3. Chapter 100, Article II, Section 100-8 of the Code of the Borough of Lewisburg, being part of Ordinance No. 1027, enacted June 17, 2014, is hereby amended by the addition thereto of Subsection E to read in its entirety as follows:
  - "E. An open or unresolved Property Maintenance Code violation related to the address where the Regulated Social Gathering is to occur."
- Section 4. Chapter 100, Article II, Section 100-11 of the Code of the Borough of Lewisburg, being part of Ordinance No. 1027, enacted June 17, 2014, is hereby amended by the addition thereto of Subsection J to read in its entirety as follows:
  - "J. Failure to clean-up the exterior premises of garbage and rubbish by 9:00 A.M. the morning following the designated start time of a Regulated Social Gathering."

Section 5. Except as amended by this Ordinance, all the provisions of Article II of Chapter 100 of the Code of the Borough of Lewisburg, being Ordinance No. 1027, enacted June 17, 2014, shall remain in full force and effect.

Section 6. All ordinances or parts of ordinances inconsistent herewith be and the same are hereby repealed.

Section 7. This Ordinance shall become effective immediately upon enactment.
